West 2.79 chains to a stake in said road; thence with the road and the Fisher line the following calls: North 70 deg. West 5.41 chains; North 60 deg. W. 4.16 chains; North 53 deg. West 2.55 chains; South 88 1/2 deg. west 5.82 chains; South 50 1/2 West 1.34 chains; South 12 deg. West 1.51 chains; North 89 deg. West 32/100 chains to a stake in the center of the road, which stake is also in Vaughn's Creek, the same being in the line of the Durnam land; thence with Vaughn's Creek and the Durnam Land North 17 deg. West 4 chains; North 5 1/2 East 1.50 chains to a stake; thence still with the Durnam line North 71 deg. West 2.40 chains; thence North 58 1/2 deg. West 1.75 chains; thence North 32 1/2 deg. West 1.30 chains; thence North 7 deg. West 1.24 chains; thence North 35 1/2 deg. east 4.94 chains to a stake in the Fisher line; thence with the Fisher line South 7 1/2 deg. east 16.72 chains to a pin; thence South 41 deg. east 6.64 chains to a pin in the line of the Pennell land; thence with the Pennell line South 5 East 5.50 chains to the beginning corner, containing 22 1/2 acres more or less.
