- 1. That R. 3. Barton, in consideration of the payment hereiniften set forth, does hereby grant, bargain, sell and release unto W. A. Seybt, his hears and assigns, all of his right, title and interest of every nature and kind by, in and to the stock of goods, fixtures, notes, accounts cash in bank, good will and all other assets of every nature and kind of the said partnership.

To is agreed unas one said W. A. Seybt shall have the right to anticipate payment of the whole or any part of said balance at any time.
- 3. It is mutually agreed that upon the execution of this contract the partnership, heretofore existing between the parties hereto shall be dissolved; that the said R. S.
