at and before the sealing of these presents by

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

S. C. State Commission on Forestry, its successors  
and assigns forever:All that piece of land or lot of land, situated,  
lying and being in Greenville County, State, aforesaid,  
containing 96 1/4 acres more or less, and bounded  
the following manner and boundaries:Commencing at a Hickory on line of Robins  
land and land of the City of Greenville and run-  
ning thence N. 36° E. 22.50 chains to center of Mountain  
Creek. Thence with meanderings of said Mountain  
Creek, S. 3.20 chains to a stone pine in place of  
chestnut gone, thence S. 58° 4' E. 37.40 chains to a  
stone S. W. thence S. 39° 16' 6.50 chains to a stone  
S. W. thence S. 32° W. 10.40 chains to a hollow c. m.,  
thence N. 63° W. 43.50 chains to a stone S. E., thence  
S. 20° E. 1.50 chains to a stone S. W.; thence S. 72° W.  
5.40 chains to the beginning of corner land tract of  
land so bounded on the north by land of Lydia Parker,  
on the East by Dr. J. G. Sharpe, City
