the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said

John W. Arrington: - All that certain piece, parcel or lot of land situate, lying and being on the north side of Crescent Avenue, Ward 6, City of Greenville, State and County aforesaid, and being known and designated as lot No. 15, and a portion of lot No. 16, as shown on a plat of Crescent Terrace, recorded in the Office of the R. M. C. for County and State aforesaid, in Plat Book 'E' at Page 137, and having the following metes and bounds, to wit: Beginning at a point in the northern line of Crescent Avenue seventy (70) feet west of Geneva Avenue and running thence N. 54 1/2 W. 269.2 feet to an iron pin; thence S. 89.07 W. 85 feet to a stake; thence S. 54 1/2 E. approximately 275 feet to a stake in northern line of Crescent Avenue which stake is 85 feet west of the point of beginning; thence with Crescent Avenue N. 84 1/2 E. 85 feet to the point of beginning and being the same lot of land conveyed to the late C. S. Haynes, worth, by deed recorded in the R. M. C. Office for Greenville County in Volume 109, page 406.

warrant and forever defend all and singular the said premises unto the said John W. Arrington, his heirs and assigns,

against myself and my heirs, and every other person whomsoever lawfully claiming, or to claim the same, or any part thereof.
