W. Holliday property on plat recorded in Plat Book "F" at page 167. Said lot having a frontage of 57 feet on Holliday Avenue, with a depth in parallel lines of 120 feet adjoining Lots #12, #14 and 16 and being same lot conveyed to Marion B. Leach, Executor of the Estate of Joseph Leach, by M. J. Mangum by deed dated May 16th, 1934 and recorded in R. M. C. Office of Greenville in Book 167 of Deeds at page 259.
