(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold, and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

J. R. Childress, his heirs and assigns, forever:
"all that piece, parcel or lot of land, lying and
being situated in Cleveland Township, Greenville
County, South Carolina, containing One and one-
fourth (1 1/4) acre, more or less, according to a sur-
vey of J. C. Miller, September 1936; and having
the following metes and bounds: Beginning
at a point in the middle of South Saluda River,
twenty-nine (29) feet from an iron pin on said
bank running thence up said river S. 51° W. 260
feet to a point in the middle of said river.
thence N. 39° 15' W. 29 feet to an iron pin on bank
of said river; thence N. 3° 15' W. across Table Rock
Ridge 210 feet to a point corner of lands of O. M.
Hardin and the lot described; thence N. 51° 0' E. 360
feet to a point corner of lands of O. M. Hardin and
the lot described; thence S. 39° 15' E. 310 feet to the
beginning, being bounded by lands of O. M. Hardin
and the South Saluda River."
