KNOW ALL MEN BY THESE PRESENTS, That,

I, Dexter A. Huff

in the State aforesaid, in consideration of the sum of Sixty-seven and 99/100 (\$67.00)

to me in hand paid at and before the sealing of these presents by Belton Light and Power Company, a corporation, the receipt of which is hereby acknowledged, have Granted, Bargained, Sold, and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Belton Light and Power Company

An easement over all that certain parcel or tract of land situate in Burklin Township, Greenville County, South Carolina, containing two and sixty-eight one hundredths (2.68) acres, more or less, nowe particularly shown on a plat made by J. E. Sirrine & Company, designated G-68, a copy of which is hereto attached and made a part of this deed. Said tract of land is bounded on the East by other lands of the grantor, on the south by other lands of the grantor and lands of E. S. Cothran, on the west by lands of E. S. Cothran, Cedar Shoals Creek intervening, and on the north by lands of Jamie Cothran.

The easement hereby granted over the said parcel or tract of land shall include the right at any and all times to raise and lower the level of the present and future ponds and dams of the grantee so as to flood, cover, overflow and impound water on any or all of said parcel or tract of land and render the same wet or soggy by the operation of its present or future hydroelectric plant and its accessories by the grantee, its successors and assigns, together with the right to clear and otherwise use such of said land as may be deemed necessary or desirable from time to time in the operation of such water power plant, together with the right to destroy, sell, use or otherwise dispose of any wood timber, brush or other material from such of said land as may be found necessary or desirable to be cleared from time to time in the operation of such water power plant, together with immunity from claims for damages by reason of the maintenance of the ponds upon said parcel or tract of land and the operation of such hydroelectric plant.
