C.* (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold, and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

*F. D. Holliday, W. O. McWhite, and W. A. Burns as trustees of West Gantt School District, No. 6-B, Greenville County, S. C.*

"All that tract or parcel or land situate, lying and being in Gantt township, County and State aforesaid, containing 5.66 acres, more or less, bounded on the north by property of W. K. Myers, on the east by the White Horse Road, on the south by a road known as the old Leenhardt road, and on the west by lands now or formerly owned by Julia D. Charles and according to plat made by L. B. Aull, Jr., Engineer, Dec. 12, 1935, having the following metes and bounds, to-wit:
