in consideration of the sum of Ten (\$10.00) Dollars,and the assumption of mortgages indebtedness herein after set forth
to me paid by Garrett Ferguson.in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these presents do grant bargain, sell and release unto
the said Garrett Ferguson, his heirs and assigns, one undivided one-half
interest in and to Butler, Township, Greenville County, State of South Carolina,about three miles east of the city of Greenville, on the Lawrence Hill
Road, containing 16.89 acres more or less, and having the following
courses and distances according to survey made April 27, 1931,
by H. J. Riddle, plat recorded in R. M. L. Office for said County in
Plat Book N, page 189.

Beginning at an iron pin at intersection of Lawrence Hill
and Woods Lake Roads, corner of lands of Sullivan and Singleten,
and running thence with Woods Lake Road S. 65-30 E. 137 feet;
thence still with said road S. 82-30 E. 918 feet to iron pin, Coe's
corner, thence with his line S. 16-20-12-26 feet to stone pedestal Smith's
corner; thence with line of Smith's York Pole and Gillian Wore,
N. 40-10-30-14-12 feet to iron pin, just east Lawrence Hill Road, thence
with said road S. 45-6-17-6-5 feet to the beginning being the same tract
of land conveyed to L. B. Ferguson, as above described, by C.
Finnan, married December 3, 1934, by deed recorded in the R. M. L. office
for Greenville County in Plat Book N, page 8, for the sum of \$100.00, to
pay a part of the consideration for said tract, the grantee assuming and

being described, as represented by the mortgage to L. F. Watson, recorded in the
R. M. L. Office for Greenville County, which mortgage amount is a total
of Eight Hundred Seventy-five (\$875.00) dollars.

on the 2nd day of December 1934, deed recorded in office of Register of Mesne Conveyance for
Greenville County, in Book 177, Page 86.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the said Garrett Ferguson, his heirs and assigns forever.

warrant and forever defend all and singular the said premises unto the said Garrett Ferguson, his
heirs and assigns, against us and our heirs, and every other person
whomsoever lawfully claiming, or to claim, the same, or any part thereof.
