This Deed, made this 24th day of June, 1935, by  
Barolina Baking Company, a corporation organized and exist-  
ing under and by virtue of the laws of the State of North  
Carolina, with principal offices in Charlotte, North Carolina,  
party of the first part, to Columbia Baking Company, a  
corporation organized and existing under and by virtue  
of the laws of the State of Delaware, with principal  
offices in Wilmington, Delaware, party of the second part,

Witnesseth:

That the said party of the first part in con-  
sideration of Ten (\$0.00) Dollars and other good and  
valuable consideration to it in hand paid by the said  
party of the second part, the receipt of which is hereby  
acknowledged, has bargained and sold and by these  
presents does bargain, sell and convey unto the said  
party of the second part and its successors and assigns,  
all those certain tracts or parcels of land in the County  
of Greenville, State of South Carolina bounded and de-  
scribed as follows:

First Tract: All that certain piece, parcel or lot of  
land, situate, lying and being in Ward Six of the City of  
Greenville, County of Greenville, and State of South Carolina,  
on Augusta Street and University Street, and having the  
following metes and bounds according to plat made by  
J. E. Surrue & Co., August 22, 1924; Beginning at an iron  
pin on Augusta Street corner of property of T. F. Cunton,  
and running thence with his line S. 60° 42' E. 285.33 ft.  
to iron pin on property of C. G. Gunter; thence still  
with his line N. 35° 11' E. 85.5 feet to iron pin on W. J.  
Petman property; thence along property of said  
Petman and G. F. Morris, R. 53-213 W. 81.7 feet  
to iron pin; thence with property of G. F. Morris N.  
37.57 E. 124.4 feet to University Street; thence with  
University Street N. 50° 31' 51" feet to iron pin;  
thence S. 37° 29' W. 127.6 feet to iron pin, property  
of W. H. Dalton; thence with line of said property  
R. 53-23 W. 153.3 feet to Augusta Street; thence  
with Augusta Street S. 33-27 W. 122.75 feet to the  
beginning corner.

Second Tract: All that certain lot of land in the  
County and State aforesaid, on the south side of  
University Street in Ward Six of the City of  
Greenville, designated as lot no 5 on a plat of  
the W. D. Workman property made by P. E. Dalton,  
Engineer, and recorded in the office of the Register  
of Deeds Conveyances for Greenville County in  
Plat Book E at page 147, and having the fol-  
lowing metes and bounds. Beginning at an  
iron pin on south side of University Street,  
corner of Lots 4 and 5, and running thence  
with line of Lot no 4, South 37.57 West 124.4 feet  
to iron pin on J. A. Cureton's property; thence with  
line of Cureton's property South 50.3.38 east  
49.8 feet to iron pin, front corner of lots 5 and 6,  
thence with line of lot no 6 north 38.05 east  
121.2 feet to iron pin on University Street; thence  
with University Street North 50 west 50 feet to the  
beginning corner.
