 has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto City of Greenville

All that certain piece, parcel or tract of land in the
 County of Greenville State of South Carolina, situated on the East side
 of Townes Street and on the West side of North Main Street and having,
 according to plat of property of B.C. Beer, Jr. and adjoining Greenville, S.C.,
 made by Dalton & Neely, Engineers, October, 1930, which plat is recorded in
 the R.M.C. Office for Greenville County in Plat Book "H", at page 177, the
 following metes and bounds, to-wit:

Beginning at a point on the East side of Townes Street, corner
 of lot no. 27, which point is 318.95 feet, more or less, South of the Southeast
 intersection of Townes Street and Ashley Avenue, and running thence
 along the Eastern side of Townes Street S. 10-57 W. 198.05 feet more or less,
 to an iron pipe on the Eastern side of Townes Street; thence S. 78-51 E.
 830 feet, more or less, to a white oak tree rear corner of lot no. 1;
 thence along the Southern side of North Main Street; thence along the
 Western side of North Main Street, along lines of lots nos. 1, 2, 3 and 4,
 129.3 feet to a point joint corner of lots nos. 4 and 5; thence along
 joint line of lots nos. 4 and 5 N. 71-52 W. 117.4 feet to a point, joint
 rear corner of lots nos. 4 and 5; thence along rear line of lot no. 5,
 N. 18-08 E. 12.4 feet to an iron pin, rear corner of lot no. 10; thence
