to it in hand duly paid at and before the sealing and delivery of these presents by the grantee, hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto J. G. Higley,

All those certain lots or parcels of land situate near the City of Greenville, in the County of Greenville, State of South Carolina lying and being about  $\frac{1}{2}$  mile northeast of the City of Greenville near the Laurens Road on the south side of Sycamore Drive known and designated as Lots nos. 79 and 100 on plat of East Lynne made by Walton & Reves, Engineers June 1931 and having, according to said plat which is recorded in the P. M. C. Office for Greenville County in Plat Book 1 at page 195, the following metes and bounds to-wit:-

Beginning at an iron pin on the south side of Sycamore Drive at the corner of Lots nos. 75 and 100, and running thence with the south side of said line S. 88-52 E. 60.3 feet to an iron pin on said driv; thence S. 35-06 W. 109.6 feet to an iron pin at corner of Lots nos. 76 and 99; thence along the north side of Lot no. 76 N. 55-45 W. 50 feet to an iron pin at corner of Lots nos. 75 and 100; thence with the line of said lots N. 35-06 E. 76.4 feet to an iron pin on Sycamore Drive, the beginning corner.

Said lots are sold subject to the building restrictions shown on the plat hereinabove referred to and subject further to the following restrictions:-

- (1) The lots herein conveyed shall be used exclusively for residential purposes.
- (2) No residence shall be erected on said lots costing less than \$1250.00.
- (3) The lots hereby conveyed shall never be sold, rented or otherwise disposed of to negroes or to persons having any percentage of negro blood.
