All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the east side of Augusta Street known and designated as lot No. 3 on plat of the property of Mrs. F. Z. Harris made by W. D. Neves, February, 1936, recorded in the R. L. C. Office for Greenville County in Plat Book "C" at page 261, and having, according to said plat, the following notes and boundaries, to-wit:

Beginning at an iron pin on the east side of Augusta Street, which pin is at the joint corner of Lots 3 and 4 on said plat, and running thence with the joint line of said lots 160 feet to an iron pin in the west line of Lot No. 23; thence with the joint line of Lots 3 and 23, 57 feet to an iron pin on the south side of an 11-foot alley; thence along the south side of said alley 141 feet to an iron pin on Augusta Street, thence with the east side of Augusta Street 60 feet to the beginning corner.


