All that certain piece, parcel or lot of land situate, lying and being in the County and State aforesaid, in Ward Two of the City of Greenville on the west side of Bennett Street and having the following dimensions, to-wit: Fronting on said Bennett Street fifty-five (55) feet and running back in parallel lines a distance of two hundred seventeen (217) feet and being Lot No. 42 of Section "H" of a plat of Stone Land Company, said plat recorded in R. M. C. Office in Plat Book "A", Page 337-345 and being one of the lots formerly owned by Stone Land Company. This is the same property conveyed to me by Fannie S. Gary by her deed dated November 23, 1922, recorded in the R. M. C. Office for Greenville County, S. C., in Deed Book 87, at Page 73.

Also all that certain lot of land situate in the County and State aforesaid, in Ward Two of the City of Greenville, and being the back portion of Lot No. 44 of Section "H" of the Stone Land Company, plat of which is recorded in R. M. C. Office for Greenville County in Plat Book "A" at pages 337-345, and having the following metes and bounds, to-wit: Beginning at a pin on the joint corner of Lots Nos. 41-42, 43 and 44, and running thence S. 20° 19' W. 97.1 feet, more or less to an iron pin; thence S. 84° 30' E. 75 feet to an iron pin; thence N. 21° E. 80.8 feet to an iron pin on line of Lots Nos. 42 and 44; thence along line of last mentioned lots N. 71° 50' W. 75 feet to the beginning corner, being a part of the land conveyed to Stella D. Stone by the Stone Land Company. This is the same property conveyed to me by Stella D. Stone by her deed dated March 30, 1920, recorded in the R. M. C. Office for Greenville County, S. C., in Vol. 63, at Page 502.
