Reeves has erected upon his lot a two-story building with a basement, and has placed one-half the southern wall of the said two-story building upon his property and one-half upon the property of Lewis A. Meyers, and it having been the intention of the parties that the said wall should become a party wall; and,

Whereas, the said Lewis A. beyers is now desirious of erecting a three-story building with a basement on his lot, as aforesaid; and;
