## RELEASE OF EASEMENT

WHEREAS, J. B. Earle has, through successive transfers, acquired the title to the premises on the West side of Euncombe Street, heretofore owned by the said Mrs. Sarah McI. N. Key, said deed being of record in the R. M. C. Office for Greenville County in Deeds Volume 179, at page 286; and

WHEREAS, since the said J. B. Earle acquired the premises hereinbefore mentioned he has closed the so-called twelve foot alley running from the South side of the said premises to Richardson Street, all of which was done with my consent and approval.

NOW, THERSFORE, in consideration of the premises and the further sum of One (\$1.00) Dollar to me in hand paid, the receipt whereof is hereby acknowledged,

I, Martin Bridges, do hereby release and relinquish unto the said J. B. Earle, his heirs and assigns, any and all right, title, interest or easement which I may have in or over the so-called twelve foot alley leading from the North side of Richardson Street to the South side of the property hereinabove referred to, and I further acknowledge that the said twelve foot alley has been closed by J. B. Earle and that all my rights therein and thereto have terminated.
