McDill as Receiver was vested in William Elliott and Robert Gage as Receivers as aforesaid; and

Whereas, by order of J. Lyles Glenn, U. S. District Judge, dated February 14, 1933. W. C. Coker was appointed Special Master and authority was given to him as said Special Master to sell certain lands belonging to the said Receivers, including lands hereinafter described; and pursuant to said order the said W. C. Coker, Special Master, did advertise said lands for sale in accordance with the terms and provisions of said order, and of other pertinent orders of said court, and the same were offered for sale on May 11, 1936 at Greenville the county seaf of Greenville County, S. C., and at such sale the said property was bid in by R. h. Hughes, Agent the highest bidder therefor, for the sum of Four Hundred (\$400.00) Dollars, and said bidder has assigned his bid to Planters Savings Bank and said sale has been confirmed by order of J. Lyles Glenn, U. S. District Judge, dated May 22, 1936 and the nurchaser is ready to comply with the bid therein;

Now, therefore, Know all men by these presents that we, W. C. Coker, as Special Master as aforesaid, William Elliott and Robert Gage as Receivers of Peoples State Bank of South Carolina, under and pursuant to the authority and power conferred upon us by the several orders of court hereinabove referred to, and for and in consideration of the sum of Four Hundred (\$400.00) Dollars to us in hand paid by the said Planters Savings Bank at and before the sealing and delivery of these presents, receipt whereof is hereby acknowledged, have granted, bergained, sold and released and by these presents do grant, bargain, sell and release unto the said Planters Savings Bank, its successors, and assigns:

An undivided one-half interest in that certain tract of land on the Middle myger River described as follows: Beginning at a stone, thence N. 75 E. 39.50 chains to a stone; thence N. 76 E. 14 chains to a stone on original line; thence S. 34 1/4 E. 16.80 chains to a red oak; thence S.  $53\frac{1}{2}$  W. 5-30 to a stone; thence S. 8 W. 10.33 chains to a stone; thence S. 75 W. 45.44 chains to a stake in the road; thence N. 65 W. 9.02 chains to a stone on said of Rutherford Road; thence N. 16 W. 21.72 chains to the beginning corner; containing 150 acres, more or less, being the same conveyed by G. W. Holtzclaw to N. D. Franks and W. F. Holtzclaw by deed recorded in Book GGC, page 18; less, nowever, 842 acres, more or less, conveyed by W. F. Holtzclaw and N. D. Franks to W. m.
