whereas, said lease provides for the remodeling of said property by the Lessee, and that the sum of whirty thousand (\$30,000) Dollars would be deposited with the wrustee for the purpose of providing funds for such work.

Now therefore; in furtherance of and in compliance with Section 2 of Article III of said indenture of lease, the Lessee, contemporaneously with the execution hereof, has deposited with the mrustee the sum of whirty thousand (\$30,000) Dellars, in trust, to be held and disbursed by said prustee in accordance with the terms and provisions of said lease, relating to the alterations and improvements to be made by Lessee to and upon the property of Lesser, as set forth in Sections 1 and 2 of Article III of said lease. The prustee acknowledges receipt of said sum of Thirty thousand (\$30,000.00) Dellars, deposited pursuant to Section 2 of Article III of said lease, and agrees to hold the same in trust and to disburse the same in accordance with the terms and provisions of Sections 1 and 2 of Article III of the aforesaid lease between the Lessor and Lessee, which is attached hereto and made a part hereof. The Lessor hereby agrees to the selection of said lease.

It is agreed that the provisions of Section 2 of Article III of said lease requiring Lessee to exhibit to the Trustee and the Lessor proper evidence of payment for furnishings and equipment for the theatre ment ioned in said lease shall mean and be construed to mean the exhibition of either cancelled checks or receipted bills (which ever Lessee elects to submit) showing payment for said furnishings and equipment.
