(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Hester Bishop Arrowood, her heirs and assigns forever;
All that piece, parcel, or tract of land in Saluda Township, County and State aforesaid, on branch of Mush Creek, waters of South Tyger River, and having the following, more or less, to-wit: (According to Plat of property of B. G. Wood, made by Dalton & Nevers, Engrs. Jan. 1931)
Beginning at an iron pin in center of Ridge Road, corner of property of Dennis Pitman, and running thence with Pitman line S. 28-00 W. 480 feet to iron pin, thence still with Pitman line, N. 38-00 W. 204 ft.; thence S. 14-00 W. 241 feet; thence, still with Pitman line N. 51-00 W. 1312 feet to stone, corner W. D. Southern land; thence with Southern line S. 10-00 W. 403 feet to stone; thence S. 37-30 E. 225 feet to stone; thence S. 21-00 E. 246 ft. to stone; thence S. 9-00 E. 193 1/2 feet to stone; thence S. 57-15 W. 351 feet to iron pin on bank of branch; thence S. 70-30 W. 361 feet to stone on branch; thence S. 27-50 E. 911 feet to Spanish Oak; thence S. 86-30 E. 725 feet to Spanish Oak; thence N. 13-45 E. 961 feet; thence N. 82 E. 129 feet to iron pin; thence N. 61-30 E. 264 ft. to iron pin; thence N. 17 E. 322 feet to iron pin; thence S. 54 E. 665 feet to stone; thence N. 17-45 E. 547 feet to iron pin; thence N. 57 W. 136 1/2 feet to iron pin on east bank of road; thence N. 25-15 E. 148 feet to center of Ridge Road; thence S. 63-30 W. 175 feet to angle in center of Ridge Road; thence N. 68-30 W. 200 feet to angle in road; thence N. 59-54 W. 538 1/2 feet to the beginning corner, containing Fifty-five and two tenths acres.
