(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

P. O. Brookshire, his heirs and assigns;  
That certain tract or parcel of land in Butler Township, said County and State, containing forty and 20/100 (40.25) acres, as delineated and shown on plat thereof by H. S. Brockman, April 14, 1936, of property of J. B. Snow Estate, and designated as Tract No. 2 thereon, as follows:

Beginning at a stone, cornering with lands of J. E. Summey, South of the Community Road leading to Bellamy, and running thence N. 40° 00' W. 657.6 feet to iron pin on Southern edge of said Community Road; thence crossing said road, S. 70-30 W. 232 feet to Persimmon on or near Northern edge of said road; thence N. 22-30 W. 834 feet to iron pin at angle of Bette Branch; thence S. 85-23 E. 407 feet to angle of said Branch or Creek; thence N. 36-30 E. 451 feet to angle of said Creek; thence N. 53 E. 246 feet to angle of said Bette Creek; thence S. 73 E. 200 feet to angle of said Creek; thence with said Bette Creek as the line, S. 51.00 E. 434.5 feet to angle; thence S. 44-05 E. 342 feet to angle; thence (at times crossing said Creek) S. 22-32 E. 343.5 feet to angle; thence S. 83.06 E. 100 feet to intersection of Belts Creek and Pool Branch; thence with Pool Branch as the line S. 64 W. 191.5 feet to angle; thence S. 54-30 W. 100 feet to angle; thence S. 33-18 W. 483 feet to angle; thence S. 25-32 W. 392 feet to stake; thence N. 58-55 W. 300 feet to stone, the beginning corner; bounded North by lands of Arch Mahaffey; North east and East by lands of Fletcher Wilson; South east and South by lands of Dick Mahaffey, and of J. E. Summey; and West by tract No. 1 on said plat. This deed is made in pursuance of authority granted in the will of J. B. Snow, deceased, and the Decree of the Court of Common Pleas for Greenville County in re O. A. Gaines, Surviving Executor, as Plaintiff, versus Epworth Orphanage, as defendant.
