All that certain lot of land on the north side of Stone Avenue, known as lot No. 31 in the City Block Book, at page 8, and described as follows:

Beginning at an iron pin on the north side of Stone Avenue at the corner of lot No. 30 and running thence in an Easterly direction with Stone Avenue 28 feet 8 inches to an iron pin; thence in a northerly direction along the line of lot of E. E. Stone 194 feet 8 inches to an iron pin corner of lot of property of W. M. Miller; thence in a westerly direction 32 feet to an iron pin; thence in a southerly direction 194 feet 2 inches to the beginning corner.
