to me, in hand paid, at and before the sealing of these presents by Bertha Orr.

The receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said Bertha Orr:

All that certain piece, parcel or tract of land, situate, lying and being in the County of Greenville, State of South Carolina, on the Mountain, about three miles from the City of Greenville, being a portion of a tract owned by Benjamin King, deceased, and designated in Plat made by H. W. Bailey on March 23rd, 1920 as tract No. 4, said Plat being duly recorded in the Probate Court Office for said County and State in the case of Benjamin J. King, Executor vs. Nathaniel Drayson, et al. Described as follows:

Beginning at a stone, Dorgan's and Summerer's corner, and running thence S. 78° E. 540 feet to a stone; thence S. 27° E. 380 feet to a stake in the center of the road, the northwest corner of Tract No. 3; thence with the center line of the road in a southerly direction to an iron pin, the northeast corner of Tract No. 2; thence with the line of tract No. 2 N. 77° W. 980 feet to an iron pin in Dorgan's line; thence, with Dorgan's line N. 32° E. 460 feet to a stake; thence N. 17° E. 505 feet to the beginning corner, being tract No. 4 as shown on said plat, and containing 16.09 Acres.

The above described land is the same conveyed to me by Edward W. Grayson on the 28th day of January, 1923, deed recorded in office of Register of Deeds for Greenville County, in Book 168, Page 157.

AND I do hereby bind myself and my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said Bertha Orr, and her heirs and assigns,

against me and my heirs, and every other person whomsoever lawfully claiming, or to claim the same, or any part thereof.
