All that certain piece, parcel or lot of land
situate, lying and being in the state and County
aforesaid, Oneal Township about three miles north
west of Mill on the west side of the Gilbreath Mill Road,
adjoining lands of Lee Smith, Manly Mason and myself,
and being a part of the same land conveyed to me
by deed from S. D. Suddeth November 20, 1909, said
deed recorded in the R. R. C. office for Greenville
County in Deed Book 5 at page 188, and having the
following courses and distances to wit:

Beginning on an iron pin on the West Bank
of the Gilbreath Mill Road on Lee Smith's line and runs
thence with said line N. 87-45 W. 360 feet to an iron
