All that piece, parcel or lot of land in Greenville Township, Greenville County,
State of South Carolina, on the White Horse Road, about three miles from Greenville
Courthouse, known as tracts Nos. 25 and 26 on the revised plat of the Yown property,
and having the following courses and distances: Beginning at a stake in the center
of the Whitehorse Road 304.7 feet north of the intersection of the White Horse Road
and Anderson Road, also corner of tract No. 27; and running thence with a line of tract
No. 27, N. 62-20 E. 281.2 feet to stake in line of tract No. 24; thence with line of
tract No. 24, N. 26-30 W. 400 feet to stake in line of tract No. 20; thence with line
