Payment for the first months rent to be made on execution of this lease.

The lessee hereby agrees to take the premises just as it stands and the lessor is not to pay any damages from leaks should any occur, and any repairs are to be made by lessee without cost to lessor.

The destruction of the premises by fire or making it unfit for occupancy or other casualty, will not affect this lease, neither will lessor have to replace building. The failure by the lessee to pay the stipulated rental within ten days from the due date thereof, shall terminate this lease, if the lessor so desires. At the expiration of this lease, or upon termination of lease as herein provided, the lessee agrees to vacate the premises immediately, and the lessee agrees to make good all breakage of glass and all other injuries done to the premises during the term except such as are produced by natural decay and agrees not to sub rent the property without the written consent of the lessor.
