

The State of South Carolina, } *Charter.*
EXECUTIVE DEPARTMENT } BY THE SECRETARY OF THE STATE.

WHEREAS, *D. A. Brown and Jake Woods, both of Greenville, S. C.*

did on the *25th* day of *January*, 19*37*, file with the Secretary of State a written Declaration signed by themselves, setting forth:

FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed Corporation is *Brown Motors Lines & Storage Co.*

THIRD: That the principal place of business is *Greenville, S. C.*

FOURTH: That the general nature of the business which it is proposed to do is *a general hauling, trucking and transfer business, both within and without the State of South Carolina, also to maintain and operate a storage and distributing warehouse, with the right to own and sell and mortgage real estate, and with all other rights and privileges of a general business Corporation as conferred upon same by the Statutory law of this State.*

FIFTH: That the amount of the capital stock is *Five Thousand (\$5,000.00)* Dollars, payable *in cash, equipment and services in the discretion and at the call of the*

SIXTH: That the number of shares into which the capital stock is divided is *fifty (50)* *Directors* of the par value of *One Hundred (\$100.00)* Dollars.

SEVENTH: That, after due notice, a meeting of the subscribers was held on the *23rd* day of *January*, 19*37*, at which a majority of all stock in value being present in person or by proxy the following were elected directors: *D. A. Brown, Jake Woods and Robert R. Bishop.*

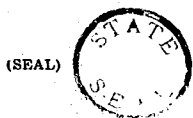
EIGHTH: That subsequently there was elected as President *D. A. Brown* as Vice-President, *Robert R. Bishop*; as Secretary, *Robert R. Bishop* as Treasurer, *Jake Woods.*

NINTH: That all requirements of Article 2, Chapter 153 Code of Laws of South Carolina, 1932, and all amendments thereto, have been duly and fully complied with, 50 per cent, of the aggregate amount of the capital stock having been subscribed by bona fide subscribers, 20 per cent, of the capital stock subscribed having been paid to the Treasurer, and three days' public notice of the intention to file this Declaration with the Secretary of State having been given in

a newspaper published in the County of *The Piedmont Greenville*

NOW, Therefore, I, W. P. BLACKWELL, Secretary of State, by virtue of the authority in me vested by the aforesaid Code and Acts amendatory thereto, do hereby certify that the said Company has been fully organized according to the laws of South Carolina, under the name and for the purposes indicated in their written declaration, and that they are fully authorized to commence business under their charter; and I do hereby direct that a copy of this certificate be filed and recorded in the office of the Register of Mesne Conveyance or Clerk of Court in each county where such Corporation shall have a business office.
