all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

All that certain piece, parcel or lot of land situate in the city of Greenville, Greenville County, State of South Carolina, having the following course, meter and bounds:

Beginning at an iron pin on the south side of McCall Street, at the northeast corner of lot #83 of Alta Vista sub-division and running thence along 77^{1/2} Siver Street S. 87-00 E. a distance of 10.9' to an iron pin, which iron pin is at the intersection of 77^{1/2} Siver Street and Pine Forest Drive; thence along the west side of Pine Forest Drive S. 145 21. 174. 4' to an iron pin in the west side of Pine Forest Drive, thence N. 87-00 W. 12.5' to an iron pin, which iron pin is at the rear south-east corner of lot #83 of Alta Vista sub-division, thence N. 145 E. along the eastern boundary of lot #83 of the Alta Vista sub-division a distance of 109.6' to an iron pin, thence N. 4-43 E. along the boundary of lot #83 of Alta Vista sub-division of 64.8' to the beginning corner.
