

TITLE TO REAL ESTATE

all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina,

situate, lying and being on Lanneau Street near McDaniel Avenue, and being known and designated as Lot No. 43 according to plat of property of the W. Q. Donaldson Estate, which Plat is recorded in Plat Book H, page 284, R. L. C. Office for Greenville County. Reference to said Plat is hereby craved for a more particular description of said lot.

The above is a portion of the same conveyed to the grantor by Sarah E. Barnes by her deed dated August 14, 1935, and recorded in Deed Book 182, page 14, R. L. C. Office for Greenville County, and this deed is made pursuant to the terms of trust contained in said deed from Sarah E. Barnes to the grantor, the said Sarah E. Barnes conveyed her interest or equity in said trust property to Romayne Barnes by instrument dated November 15, 1935 and recorded in Deed Book 255, page 231, R. L. C. Office for Greenville County.

The following restrictions shall be imposed against said lot which shall not be construed as a forfeiture for the violation thereof, but are merely imposed for the benefit of all lot owners in this subdivision:

1. The above lot shall be used only for residential purposes.
2. The above property shall not be leased, rented, sold or otherwise disposed of in any manner to persons of African descent.

The grantee is to pay the 1937 State and County taxes.
