near the City of Greenville, known and designated as Lot No. 34 of the subdivision known as Augusta Circle, as shown on plat of record in the P. M. S. Office for Greenville County, South Carolina in Plat Book "D" at page 23, and having, according to said plat, the following metes and bounds:
