all that piece, parcel or lot of land in the Township, Greenville County, State of South Carolina,

about 15 miles from Greenville Courthouse, S.C. and having the following metes and bounds to wit:

Beginning at a pin in line ofula Bradley's corner; thence with C. C. Wilson N 14° W. 44 1/2 feet with David Wilson, formerly C. C. Wilson to a pin corner of David Wilson; thence again with David Wilson line, formerly James Mc Mahan S. 79-38 E. 200 feet to a stone on side of road Julia Bradley corner; thence with the road and Julia Bradley line S 10-30 W. 435.6 feet to the beginning corner and containing one acre, according to survey of H. Beaumont Drake, survey dated December 1, 1939.
