to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinabove named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto H. T. HICKMAN

All those three certain pieces, Parcels or lots of land situate in Greenville Township, County and State aforesaid, being situate on King Street in what is known as Westview Heights and known and designated as lots Nos. 30, 31 and 33 as shown on plat made by Dalton & Neves, July 1925, and having the following mates and bounds according to said plat, to wit:

Beginning at an iron pin on King Street 50 feet from Valley Street, joint corner of lots Nos. 19 and 20 and running thence with King Street, N. 46° 34' W. 150 feet to corner of lot 23; thence with the line of lot 23, S. 43° 30' W. 150 feet to joint corners of lots 22, 23, 53 and 54; thence with rear line of lots 54, 55 and 56, S. 46° 34' E. 150 feet to joint corners of lots 19, 20, 56 and 57; thence with the joint lines of lots 19 and 20, N. 43° 30' E. 150 feet to the beginning corner.
