"All that certain lot of land situate in County
and State aforesaid, near the City of Greenville,
being as Lot No. 21 of Mountain View Land Company's
subdivision as shown on plat, the said plat being
recorded in R. M. C. Office for Greenville County, in
Plat Book "B", Page 160, and having the following meter
