unto the said Lillian Clement Hunt, her heirs and assigns

all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina,  
and in the Town of West Greenville, as follows:

Lot no 1: beginning 29 $\frac{1}{4}$  feet from an iron pin  
which lies about 105 feet in an easterly direction  
from Bob Street, adjoining land of Mrs Alice T.  
Smith (or formerly Mrs Alice L. Smith) and run-  
ning thence S. 167-30 E. 29 $\frac{1}{4}$  feet to a pin; thence  
S. 22-45 W. 67 $\frac{1}{2}$  feet to a pin; thence N. 67-30 E.  
29 $\frac{1}{4}$  feet to a pin; thence N. 22-45 E. 67 $\frac{1}{2}$  feet to  
beginning corner same which was conveyed to  
grantor Julius H. Davis by C. J. Giles deed  
recorded in deed book 134 page 341.

Lot no. 2, lot on Pack's Alley beginning at a pin  
on south side of Pack's Alley (same being northeast  
corner of the Lillian McBrody lot described in  
a deed to Julius H. Davis recorded in deed book  
152 at page 585) and running thence with  
said Alley S. 61-05 W. 67.6 feet to a pin; thence  
S. 27-27 E. 43.8 feet to a pin; thence S. 57-24 E.  
59.7 feet to a pin; thence N. 34-13 E. 36.4 feet  
to a pin; thence N. 23-15 W. 79.7 feet to the  
beginning corner, this is a part of the lot  
conveyed to Julius H. Davis, by Lillian McBrody  
deed recorded in deed book 152 page 585  
R. M. C. office said Greenville County.

This is the same land which was  
conveyed to Charles French Jones, Sr. by
