described as follows: Bounded on East Sam Meridith,
Bounded on West J. H. Kilgore,
Line From C. F. Verdin to A. M. Parker.

Also the right, privilege and authority to cut or trim trees along said line necessary to keep the wires thereof clear at least thirty (30) feet.

PROVIDED, however, any damage (other than tree damage) to the property of the undersigned, caused by the said authority in maintaining or repairing said electric transmission line, shall be borne by said authority, its successors and assigns.
