TITLE TO REALESTATE

All of our respective undivided right, title, interest and estate, both present and future, of, in and to that certain lot of land, with the buildings thereon, in the Town of Greer, Chick Springs Township, said County and State, designated as Lot No. 1 on a plat of the property of the T. C. Littlefield Estate, prepared by H. S. Brockman, Surveyor, June 16, 1936, and on which stands the old home of the said T. C.
