KNOW ALL MEN BY THESE PRESENTS, That, I, Elizabeth J. McClenaghan, in the State aforesaid, in consideration of the sum of One Dollar and a division of real estate of James H. Johnson, Sr., deceased, to me in hand paid at and before the sealing of these presents by James H. Johnson, Jr., (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said James H. Johnson, Jr., all my right, title and undivided one-half interest of, in and to the following parcels of real estate:

Parcel 1.

"All that piece, parcel or lot of land in Greenville County, South Carolina, in Ward 6 of the City of Greenville, at the northeast corner of McKay St. and Burns St., being known and designated as Lot #10 on plat of property of R. J. Williams, made by R. E. Dalton, Engineer, in November, 1924, and having according to said plat the following metes and bounds:- BEGINNING at an iron pipe at the northeast corner of McKay St. and Burns St., and running thence along Burns St. N. 12-31 W. 146.2 ft. to a bend in said street; thence N. 8-05 E. 70.3 ft. to an iron pipe at corner of S.
