Guest, Anna Guest and Lillie Barnett an undivided one seventh interest; and to them, respectively, their heirs and assigns, all of that certain tract, or parcel of land, situate in Paris Mountain Township in the County and State aforesaid, and more particularly described as follows:

Beginning on the White Horse Road and being a part of the tract with thre residence situated thereon in which the late James B.
