TITLE TO REALESTATE

STATE OF SOUTH CAROLINA, COUNTY OF GREENVILLE.

Smith, County Treasurer of said Greenville County, did issue his warrants directed to the Delinquent Tax Collector for said County and State by authority of the acts of the General Assembley of South Carolina and the statute laws of said State, against J. D. Rudisill, et al, defaulting taxpayers of said County, strictly charging and commanding said Delinquent Tax Collector of said County to levy by distress and sale of the lands of the said J. D. Rudisill. et al tax defaulters, the sum of Eighty seven and 53/100 dollars (\$87.53) including the penalties on said tax executions for the years 1926 through 1934 together with charges and costs thereof; and

WHEREAS, by virtue and authority of said warrants W. A. Hopkins the then delinquent tax collector of the State and County aforesaid, did on the 12th day of May, 1936 seize and take exclusive possession of the said property against which said taxes were assessed and levied, as hereinafter described, and on Sales day of the month of June during the usual hours of sale, after due advertisement, sell the same to R. Ashmore Delinquent Tax Collector of and for the County and State aforesaid, in consideration of the premises, and the sum of One hundred and twenty dollars to me paid by the said grantee R. A. Patterson, have granted, bargained, sold and released, and by these presents do grant, sell, bargain and release unto the said grantee, R. A. Patterson, his heirs and assigns:

All that lot, piece, or parcel of land in the County of Greenville, State of South Carolina known and designated as lots numbers 207, 208, 209, 210, 211, 215, 215, 218 and 219 of plat #4 of the property of the Tryon Development Co., known as Lake Lanier made by George Kershaw. C. E. and duly recorded in the office of the Register of Mesne Conveyance for said County.

Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

To Have and to hold all and singular the premises hereby granted, with the appurtenances, unto the said R. A. Patterson, their heirs and assigns, forever, according to the form in force and effect of the laws and usages of the State of South Carolina in such cases made and provided.
