1723 PROCEEDINGS-JULY 1938-1939

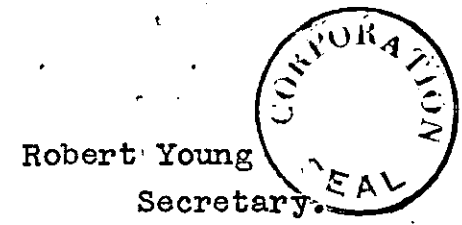
