the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said B. P. Edwards

All that piece, parcel or lot of land situate lying and being in the County and State aforesaid, in Greenville Township and fronting on State Highway number 13, described as follows:

Beginning at an iron pin on State Highway number 13 two hundred feet from line of Thurston property and running with line of lot number 4, 150 feet to an iron pin; thence westward 50 feet to corner of lot number 6; thence Southward 150 feet in a line parallel to first line herein to a pin on State Highway number 13; thence Eastward facing on said highway 50 feet to the beginning corner. Being known and designated as lot number 5 as is shown by plat recorded in the R. M. C. Office in and for Greenville County Plat Book "I" at pages 56 & 57. Nevertheless upon the following conditions, however, which conditions are a part of the consideration for this deed;

(1) That said lot of land is to be used for residential purposes only.

(2) The property conveyed shall never be sold or rented or otherwise disposed of to any person or persons of African descent.

The above described land is the same conveyed to me by R. B. Grumbles on the 10th day of May 1938, deed recorded in office of Register of Mesne Conveyance for Greenville County, in Book 203, Page 364

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the said B. P. Edwards, his heirs and assigns, forever.

AND I do hereby bind me and my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said B. P. Edwards, his heirs and assigns, against me and my heirs, and every other person whomsoever lawfully claiming, or to claim the same, or any part thereof.

heirs and assigns, all her interest and estate, and also her right and claim of Dower of, in, or to all and singular the premises within mentioned and released.

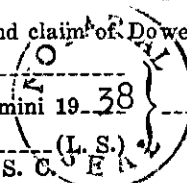
