All that certain piece, parcel or lot of land on the west side of 8th Avenue
in Judson Mills No; 2 Village, in the County of Greenville, State of South Carolina, being
known and designated as Lot No. 13 of Block D as shown on plat of Judson Mills No. 2 Village
made by Dalton & Neves, Engrs., in March, 1939, which plat is recorded in the R. M. C. Office
for Greenville County in Plat Book K at pages 1 am 2, and having, according to said plat, the

Beginning at an iron pipe on the west side of 8th Avenue, joint corner of Lots
