

THIS SUPPLEMENTAL AGREEMENT made this 18th day of Oct. 1939, by and between Letha J. Revis, of 101 Stone Avenue, in the City and County of Greenville, South Carolina, hereinafter called "Lessor", and Shell Oil Company, Incorporated, a Virginia corporation having a usual place of business at 50 West 50th Street in the City, County and State of New York, hereinafter called "Shell".

WITNESSETH THAT:

BY indenture dated April 27, 1939, and recorded in the Office of the Recorder of Mesne Conveyances for Greenville County, South Carolina, in Deed Book 210, Page 422, Lessor leased to Shell the premises situated at the intersection of Stone Avenue and Elizabeth Street in Greenville, County of Greenville, State of South Carolina, more particularly bounded and described in said lease.
