described as follows: Approximately 95 acres, bounded on the
North by the land of Martin Vaughn
East by the land of Estelle M. Knight
South by the land of A. Butler & Brown
West by the land of C. S. Hahn

Also the right, privilege and authority to cut or trim trees along said line necessary to keep the wires thereof clear at least Ten (10) feet.
