BILL OF SALE.

Whereas, at a meeting of the stockholders of The Laurens Road Water Company held at Greenville, S. C., on March 23rd, 1940, at which meeting the holders of all the capital stock of the said corporation were present, a resolution was unanimously adopted, authorizing and directing the undersigned officers of the corporation to transfer and convey to City of Greenville, S.C. the property hereinafter described:

NOW, THEREFORE, pursuant to the authority vested in us by the above mentioned resolution, this conveyance is made.

KNOW ALL MEN BY THESE PRESENTS That The Laurens Road Water Company, a corporation chartered under the laws of the State of South Carolina, with its principal place of business in the City of Greenville, S. C., in consideration of the sum of One (\$1.00) Dollar to it in hand paid at and before the sealing and delivery of these presents, by City of Greenville, S.C. (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto City of Greenville, S. C., the property hereinafter described, located in Greenville County, South Carolina:-

All that certain 6 inch pipe or water line located in and along the Laurens Road and being approximately 5,700 lineal feet, extending from the city limits of Greenville, S. C. to the intersection of Lowndes Hill Road, including all fittings, etc. which go to make up the said water line; and also all the right and interest of The Laurens Road Water Company in and to the rights-of-way and easements heretofore granted to said corporation by South Carolina State Highway Department, authorizing the laying, maintenance and operation of said water pipe line in said road.

TO HAVE AND TO HOLD the property hereinabove described unto the said City of Greenville, S. C., its successors and assigns forever.

Poe, Jr., Vice President, and T. C.
