All that certain piece, parcel or lot of land situate lying and being in the County and State aforesaid, in Chick Springs Township, being known and designated as lot No. 26 on plat of lands of P. L. Bruce and C. O. Berry, which plat is recorded in the R. M. C. Office in Plat Book J at page 54, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the east side of a public road, designated as said plat as Paris Mountain Road, which road leads by Paris School, and running thence S. 71 1/2 E. 340 feet to an iron pin on the P. & N. Ry. right-of-way; thence along said right-of-way S. 44-45 W. 250 feet to iron pin on said road; thence along said road N. 4-30 W. 400 feet to point of beginning. Being one of the lots conveyed to me by P. L. Bruce and C. O. Berry by deed dated March, 1939.

The grantee herein, her heirs and assigns, shall have the right to tap in to the water line running through the grantor's other lot (lot No. 25), directly across the above mentioned road from the property herein conveyed, at any point she sees fit, and shall have the right to enter lot 25 from time to time after said tap is made, for the purpose of repairing and maintaining the water line of lot 26.
