All that certain lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot No. 30 on Plat of Property of H. G. Stevens made by W. J. R. ... Surveyor, April 1941, and recorded in Plat Book M, page 9, and having the following metes and bounds according to said Plat:
