Eugene E. Stone, III, his heirs and assigns:

All that piece, parcel or lot of land on the East side of the Paris Mountain Road, about three miles from the City of Greenville, S. C., containing 0.44 of an acre, more or less, according to a plat thereof made by W. J. Riddle, dated Sept. 5, 1941, and according to said plat having the following metes and bounds, to-wit:

Beginning at an iron pin on the Paris Mountain Road at intersection of another road and across from Church, and running thence N. 62-30 E. 313.6 feet to an iron pin on Paris Mountain Road, on line of W. A. Hudson property; thence S. 43-45 W. 348.8 feet along the line of W. A. Hudson property to an iron pin on road; thence N. 19-20 W. 31 feet to an iron pin; thence N. 19-20 W. 130 feet to an iron pin; thence N. 19-20 W. 22.4 feet to the beginning corner.
