the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said

Daisy P. Hester and her heirs and assigns:

All my right, title and interest in and to all that certain piece, parcel or tract of land situate, lying and being in Greenville County, State of South Carolina, containing 3/4 acres, more or less, and being known as tract No. 3 of the Steven Poole property, according to survey and plat by W. A. Hester, Surveyor, dated March 19, 1937, and having the following courses and distances, to-wit:

Beginning at a stake, southern corner of said tract, and running thence N. 29 E. 5.30 chs. to a poplar on Enoree River at mouth of branch; thence up said branch as the line N. 15 W. 11 chs. to bend; thence N. 43 E. 6.50 chs. to bend; thence N. 10 W. 7 chs. to bend; thence N. 7 1/2 E. 6.50 chs. to black gum of branch; thence N. 89 1/2 E. 9.25 chs. to pine; thence N. 4 W. 5.85 chs. to W. O.; thence S. 77 W. 9.40 chs. to dogwood; thence N. 78 W. 8.70 chs. to stone; thence S. 19 1/2 W. 19.50 chs. to R. O. stump; thence S. 7 1/2 E. 5 chs. to stake on Enoree River; thence S. 47 E. 6.90 chs. to stake on bank of river; thence S. 7 1/2 E. 7.75 chs. to a post; thence S. 26 E. 4.05 chs. to the beginning corner.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.
