BEGINNING at an iron pin on the East side of Whitney Street (Formerly Hoover Street), joint front corner of Lots No. 3 and 4 of Block A, which iron pin is 310 feet South of the Southeast corner of the intersection of Edison and Whitney Streets, and running thence with the line of Lot No. 4, N. 34-53 E. 125 feet to an iron pin; thence 3; thence with the line of Lot No. 2, S. 41-48 W. 125 feet to an iron pin on the East side of Whitney Street; thence with Whitney Street, N. 56-01 W. 80 feet to the beginning corner.

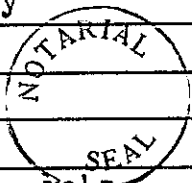
