to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto J. D. Williams and Margaret Williams, their heirs and assigns:-

All that certain piece, parcel or lot of land situate, lying and being on the Northeast side of Sycamore Drive near the City of Greenville, in the County of Greenville, State of South Carolina and being known as Lot No. 145 on plat of East Lynne Addition made by Dalton & Neves, Engineers May, 1933 and recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book H at page 220, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the Northeast side of Sycamore Drive at joint front corner of Lots 144 and 145, and running thence with the line of Lot 144, N. 32-31 E. 226 feet to an iron pin on the Southwest side of Ridgeway Drive; thence with the Southwest side of Ridgeway Drive S. 37-32 E. 80 feet to an iron pin; thence with the line of Lot 146, S. 39-48 W. 199.8 feet to an iron pin on the Northeast side of Sycamore Drive; thence along the Northeast side of Sycamore Drive, N. 58-29 W. 50 feet to the beginning corner.

This property is conveyed subject to the following building restrictions:

(1) The lot herein conveyed shall never be sold, rented, used or disposed of to negroes or persons of African descent.

(2) No residence shall be erected on said property costing less than \$1,250.00.

(3) The building line as shown on the recorded plat above referred to and also other restrictions shown on said plat are to be strickly adhered to .

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee(s) hereinabove named, and their heirs and assigns forever.

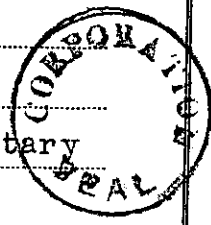
